



# House rules

- Everyone working at **Patrem Filia bvba** , whether or not on a self-employed basis, is in possession of the certificate "**Hygiene procedures for tattoos and piercings**".
  - We only work by appointment, a deal is an appointment when the deposit has been paid.
  - It is not allowed to smoke and/or consume alcohol in the studio. If it turns out at the time of the appointment that there is use, the appointment and the advance payment will expire.
  - We do not put tattoos on people under the age of 16. and no piercings under the age of 14.
  - If you are **under 18 years old** , you must always be accompanied by your **parents or guardian**.
  - Before the start of the treatment, you must complete and sign a consent form, together with your parents or guardian.
  - You will also need to identify yourself with your ID or passport, of which we will make a copy. (This is an obligation of the insurance), is kept for 1 year.
  - We do not post racist texts and/or slogans.
  - Patrem Filia only works with approved materials, in accordance with European regulations.
  - Inks are compliant with the REACH regulations.
1. An advance payment is mandatory.
    1. Design Tattoo/Tattoo 75€ - 400€.
    2. PMU 80€ - 200€.
    3. Advance payment can be made by bank card or cash in the shop or by bank transfer.
    4. Bank : IBAN BE07 7360 2897 4166.
    5. Or with the payment link sent to you.
  6. The advance payment will be deducted from the final price at a later date.
    7. If you have multiple sessions, the advance payment will remain until the last session.
  2. An advance will not be refunded after cancellation, but will be returned in the form of a gift voucher after deduction of the expenses incurred.
  3. Costs incurred consist of: Administration costs 35€ (at all times), and e.v.t. hours worked on a design at 50€ p/h.
  4. Tattoo costs: 50% design (max 3 examples) and 50% placement of the tattoo.
    1. More examples is an additional cost: á 25% of the T.T.K.. (total tattoo costs and p/pc).
    2. After approval, a design is prepared in its entirety. (stencil + consent form)
    3. Small changes larger design: max 2, more is extra cost 10%(min.35€) of T.T.K..
    4. Changes after approval of the design at 50% of the T.T.K.
    5. Complete modification of design after approval of new calculation, new deposit with a minimum of 75€

**If your appointment is not cancelled or rescheduled in time (72 hours from the start), a penalty will be charged, after payment your appointment will be rescheduled, in case of no/late payment (within 3 months) your deposit will expire.**

**In case of illness you provide a doctor's certificate, in case of certificate nothing will be charged and we will schedule a new appointment.**

**If you are more than half an hour late, the same conditions apply.**

**Fines:**

Appointments scheduled until 1 hour: 75€, 2 hours: 150€ 3 hours: 225€ and day sessions: 400€

1. We do not work per hour but agree on a fixed price per tattoo. (no surprises)
2. Refreshment existing tattoos per hour.
1. Own designs and designs by the shop are only set 1x.
2. Touch-up of a tattoo is done 1x and free of charge after min. 8 weeks and within six months.
3. Touch-up finger and foot tattoos is for a small fee (35€), otherwise done by us from 75€.
4. Updating of PMU happens 1x after 8wks, 2nd Update of PMU is 75€, then after 1/2/3 years to max. 50% discount total amount.
5. In exceptional cases, the pmu does not "catch" ink, this is entirely at your own risk.
6. Update after half a year from 50€ (at hourly rate)
- Taking care of your tattoo/piercing/pmu is your own responsibility and you can download the guidelines for after-care for free, care products are included in the price.
